The Arizona Department of Environmental Quality (ADEQ) has completed the public notice process for this application and in accordance with Arizona Administrative Code (A.A.C.) R18-2-307(A) has issued and sent the proposed final permit to the Environmental Protection Agency for a 45 day review period.

According to A.A.C. R18-2-302(G), when ADEQ issues a proposed final permit, the applicant may begin actual construction, but not operation, of the source requiring the permit. The decision to issue a proposed final permit is an appealable agency action under A.R.S. § 41-1092. The appealable action is limited to any new construction authorized under A.A.C. R18-2-302(G). Operation can begin upon the issuance of the final permit. The issuance of the final permit after the EPA 45 day review period will also be an appealable agency action. ADEQ will notify anyone who commented during the public comment period when the final permit is issued.

You have a right to request a hearing and file an appeal under A.R.S. § 41-1092.03(B). You must file a written Request for Hearing or Notice of Appeal within 30 days of your receipt of this Notice. A Request for Hearing or Notice of Appeal is filed when it is received by ADEQ's Hearing Administrator as follows:


The Request for Hearing or Notice of Appeal shall identify the party, the party's address, the agency and the action being appealed and shall contain a concise statement of the reasons for the appeal. Upon proper filing of a Request for Hearing or Notice of Appeal, ADEQ will serve a Notice of Hearing on all parties to the appeal. If you file a timely Request for Hearing or Notice of Appeal you have a right to request an informal settlement conference with ADEQ under A.R.S. § 41-1092.06. This request must be
