

# APPLICATION PACKET FOR AN AIR QUALITY PERMIT TRANSFER

#### INTRODUCTION

This application packet has been designed to assist in the transfer of air quality permits. A permit may be transferred to another person if the person who holds the permit submits a transfer application at least 30 days before the proposed transfer. In accordance with Arizona Administrative Code (A.A.C.) R18-2-323, if the transfer is not denied within 10 working days after receipt of the application, it shall be deemed approved.

Please note that an application packet must be completed for each plant that will be transferred to the new Permittee.

#### **DISCLAIMER**

This application packet does not waive the rights of the Director as provided under A.A.C. R18-2-323 to request that additional information be submitted by the applicant to assist in the processing of an application for an air quality permit transfer. Any applicant who fails to submit any relevant facts or who has submitted incorrect information in an application shall, upon becoming aware of such failure or incorrect submittal, promptly submit such supplementary facts or corrected information. If there are any differences in form between this application packet and Title 18, Chapter 2 of the A.A.C., the A.A.C. shall take precedence.

#### APPLICATION INSTRUCTIONS

#### 1. INSTRUCTIONS

This application packet consists of the following three forms which must be completed in order to file a complete air quality permit application:

## FORM A: Request for an Air Quality Permit Transfer

This form shall be completed in full by the current Permittee and is used to provide information that is specific to the current Permittee. In addition, the form also identifies the permits that will be transferred, and the provisions that will be made for the payment of overdue fees.

#### FORM B: Acceptance of an Air Quality Permit Transfer

This form shall be completed in full by the new Permittee and is used to provide information that is specific to the new Permittee.

#### **FORM C:** Equipment List

Both of the following tables shall be completed in full by the current Permittee:

Table C.1 of this form shall be used to provide a list of all equipment located at the facility that will be transferred from the current Permittee to the new Permittee. This list shall include the type of equipment, make, model, maximum rated capacity, serial number, manufacture date, and equipment identification number of each piece of equipment.

Table C.2 of this form shall be used to identify those pieces of equipment that will not be transferred to the new Permittee. This list shall also include the type of equipment, make, model, maximum rated capacity, serial number, manufacture date, and equipment identification number of each piece of equipment. In addition, the current Permittee shall identify the reasons that the equipment will not be transferred, as well as its future operational and air quality permit statuses.
