Notes:

#1 = Specific tampering checks are not applicable to all vehicles in a specific category and are dependent on how the vehicle was originally equipped. Tampering includes failure to repair any malfunctioning emissions control system or device. The cost to repair an emissions control system or device which has been tampered cannot be included in the RCL for a waiver. Definitions for abbreviations: AIS = Air Injection System, Cat = Catalytic Converter, Evap = Evaporative Emissions System, PCV = Positive Crankcase Ventilation.

Notes (continued):

- #2 = A functional gas cap test will be performed on all vehicles with a non-vented fuel system, vehicles operated exclusively on propane or natural gas are exempt from the gas cap test, all vehicles with a vented fuel system will receive a visual gas cap test.
- #3 = RCL is the abbreviation for Repair Cost Liability
- #4 = Vehicles operated exclusively on propane or natural gas are exempt from the evaporative pressure test.
- #5 = OBD is the abbreviation for On-Board-Diagnostic System. Vehicles with excessive unset readiness indicators will be rejected from testing. (Monitors indicate the OBD system's readiness to be audited. Model Year (MY) 2000 and older may have no more than 2 monitors unset. MY 2001 and newer may have no more than 1 unset monitor.)
- #6 = DLC is abbreviation for the Diagnostic Link Connector on vehicles equipped with an Onboard Diagnostic System.
- #7 = Alternative Bi-Fuel Vehicles shall be tailpipe tested on each fuel the vehicle is capable of being operated on, test type shall be the IM147 or Loaded test depending on Area, except Idle Tests shall be performed on vehicles that cannot be tested on a dynamometer.
- #8 = Twice Standard: A Waiver may not be issued to a vehicle exhibiting emissions greater than two times the standard for that classification.
