## **Analyzer Facility Registration**

(Registration of Emissions Analyzers and Opacity Meters)

(A.A.C. R18-2-1027; LTF rule table 4, category 1)

This license is subject to license time frames (LTF) statute (A.R.S. §§ 41-1072 through 41-1079) and rule (A.A.C. R18-1-501 through R18-1-525). The following are the steps that an applicant must take to in order to obtain this license:

Determine if this is a license you wish ADEQ to grant you.

1. Complete the enclosed application form. **Type or Print** all entries. Return the completed application to the appropriate address printed at the top of the application.
2. Respond promptly to all requests for additional information by ADEQ during the application review process.

Licensing Time Frames requirements for this license:

Administrative Completeness Review Time Frame	10 Business Days
Substantive Review Time Frame	<u>10 Business Days</u>
Overall Time Frame	20 Business Days

The LTF rule provides for the time frame suspension under certain limited circumstances to allow an applicant the opportunity to correct an application deficiency rather than face a summary denial under LTF statute. Please refer to the rule for more information.
