

**NOTICE OF 30-DAY PUBLIC COMMENT PERIOD  
EAST CENTRAL PHOENIX 40<sup>TH</sup> AND OSBORN  
WATER QUALITY ASSURANCE REVOLVING FUND (WQARF) SITE  
PROPOSED REMEDIAL OBJECTIVES (RO) REPORT**

The Arizona Department of Environmental Quality (ADEQ) has completed the proposed remedial objectives (RO) report for the East Central Phoenix (ECP) 40<sup>th</sup> and Osborn Water Quality Assurance Revolving Fund (WQARF) site in Phoenix, Arizona [Arizona Administrative Code R18-16-404(C)(1)(c)]. Proposed ROs are the clean-up goals determined for a specific site. They are identified based upon information provided during the public meeting and public comment period for the draft remedial investigation (RI) report and any other information received, and consider current and reasonably foreseeable uses of land and waters of the state.

The ECP 40<sup>th</sup> And Osborn WQARF site consists of a plume located in Phoenix. The plume is approximately a circle about 400 feet in diameter encompassing the Salt River Project Well 17.9E-7.5N. Contaminants of concern at the site are tetrachloroethene.
