**NOTICE OF 60-DAY PUBLIC COMMENT PERIOD  
EAST CENTRAL PHOENIX 40TH STREET & INDIAN SCHOOL ROAD  
WATER QUALITY ASSURANCE REVOLVING FUND (WQARF) SITE  
DRAFT REMEDIAL INVESTIGATION (RI) REPORT  
SOLICITATION OF REMEDIAL OBJECTIVES (RO)**

The Arizona Department of Environmental Quality (ADEQ) has released the draft Remedial Investigation (RI) report for the East Central Phoenix 40th Street & Indian School Road Water Quality Assurance Revolving Fund (WQARF) site in Phoenix, Arizona [Arizona Administrative Code R18-16-404(C)(1)(b)]. An RI report is prepared to identify the nature and extent of contaminated soil and waters of the state and the sources thereof; identify current and potential impacts to public health, welfare and the environment; identify present and reasonably foreseeable future uses of the land and groundwater; and obtain and evaluate any other information necessary for identification and comparison of alternative remedial actions. Proposed remedial objectives (RO) are solicited from the public and are the clean-up goals determined for a specific site and consider the current and reasonably foreseeable future uses of land and waters of the state.

The 40th Street & Indian School Road WQARF site consists of contaminated groundwater plume located in the vicinity of 40th Street near Indian School Road. The plumes are bounded Devonshire Avenue to the north, 40th Street to the east, East Picadilly Road to the south, and 38th Place to the west. The current contaminant of concern in the soil is tetrachloroethene (PCE).

All comments received will be compiled in a responsiveness summary to be included in the final RI Report. **Comments must be postmarked or received by ADEQ no later than 5 p.m. on February 16, 2015**
