## NOTICE OF THE OPPORTUNITY TO COMMENT ON THE PROPOSED LANDFILL OPERABLE UNIT REMEDIAL OBJECTIVE REPORT BROADWAY-PANTANO WATER QUALITY ASSURANCE REVOLVING FUND (WQARF) REGISTRY SITE

Arizona Department of Environmental Quality (ADEQ) has completed the Proposed Landfill Operable Unit (LOU) Remedial Objectives (RO) report for the Broadway-Pantano WQARF Site in Tucson, Arizona [A.A.C. R18-16-406(I)]. Proposed ROs are identified to consider the current and reasonably foreseeable uses of land and waters of the state as determined during the public comment period for the draft Remedial Investigation (RI) report.

The LOU of the Broadway-Pantano WQARF Site consists of the Broadway North Landfill (BNL), the Broadway South Landfill (BSL), and the vadose zone under each landfill. The BNL is bounded approximately by Speedway Boulevard to the north, the Pantano Wash to the east, Broadway Boulevard to the south, and Kolb Road to the west. The BSL (located south of the BNL) is bounded approximately by Broadway Boulevard to the north, the Pantano Wash to the east, 22<sup>nd</sup> Street to the south, and Prudence Road to the west. The BNL and the BSL are the main sources of the Site groundwater contamination with tetrachloroethene (PCE), trichloroethene (TCE), and vinyl chloride above the Arizona Aquifer Water Quality Standards.

ADEQ is accepting comments from the public on this Proposed LOU RO report from March 5, 2014 through April 3, 2014. After the 30-day public comment period, ADEQ will prepare and provide notice of the availability of the final LOU RI report. The final RI report will contain data gathered during the LOU RI, the final RO report, and any responsiveness summaries compiled to address comments, issues or concerns raised in the community involvement process.
