**Extension of Public Comment Period  
for Draft Landfill Operable Unit (LOU) Remedial Investigation Report and  
Solicitation of LOU Remedial Objectives  
Broadway-Pantano Water Quality Assurance Revolving Fund (WQARF) Registry Site**

The Arizona Department of Environmental Quality (ADEQ) is extending the public comment period for the Draft LOU Remedial Investigation (RI) Report and solicitation of LOU Remedial Objectives (ROs) (clean up goals) for the Broadway-Pantano WQARF Registry Site (Site) in Tucson, Pima County, Arizona.

The Site is located in east-central Tucson, and is bounded approximately by Speedway Boulevard to the north, the Pantano Wash to the east, Calle Madero to the south, and Craycroft Road to the west. The Site consists of the closed Broadway North Landfill (BNL) and the closed Broadway South Landfill (BSL), and the associated groundwater containing tetrachloroethene (PCE), trichloroethene (TCE) and vinyl chloride above a regulatory standard. The BNL, BSL and vadose zone beneath the BNL and BSL are the sources of the Site groundwater contamination and are collectively referred to as the LOU.

This LOU RI Report was prepared to identify the nature and extent of contamination at the LOU; identify current and potential impacts to public health, welfare and the environment; identify present and reasonably foreseeable uses of impacted land; and obtain and evaluate any other information necessary for identification and comparison of alternative remedial actions (the Groundwater RI Report was finalized in June 2012).

ADEQ will receive comments on the Draft LOU RI Report and recommendations for proposed LOU ROs for an additional 30 days until February 26, 2014. A copy of the Draft LOU RI Report will be available for review through Wednesday, February 26, 2014 at the following locations:
