Pursuant to Administrative Law Judge Decision No. 10A-RP078-DEQ, ADEQ issues written interim decisions to the Stakeholders' requests as set forth below:

RID ERA Work Plan: ADEQ's June 24, 2010 Conditional Approval of a WQARF ERA Work Plan for the West Van Buren Registry Site is ADEQ's written interim decision.

RID Public Health Exposure Assessment and Mitigation Work Plan: ADEQ's June 23, 2011 letter with the subject line of "Review of ERA, Public Health Exposure Assessment and Mitigation Work Plan , West Van Buren Area, Water Quality Assurance revolving Fund Registry Site" is ADEQ's written interim decision.

RID Well Investigation Work Plan: In light of the fact that RID withdrew its request for ADEQ review of the RID Well Investigation Work Plan, ADEQ has not completed a technical review of the document, or rendered any decision related to the document. As a result, no written interim decision has or can be made.


