## 60-DAY PUBLIC COMMENT PERIOD NOTICE OF RELEASE OF THE DRAFT REMEDIAL INVESTIGATION REPORT AND SOLICITATION OF PROPOSED REMEDIAL OBJECTIVES FOR THE SHANNON ROAD/EL CAMINO DEL CERRO WATER QUALITY ASSURANCE REVOLVING FUND (WQARF) SITE

The Arizona Department of Environmental Quality (ADEQ), pursuant to Arizona Revised Statutes §49-287.03 and Arizona Administrative Code R18-16-404(C)(1)(b), has released the draft Remedial Investigation (RI) Report for the Shannon Road/El Camino del Cerro WQARF Site in Tucson, AZ. An RI Report is prepared to identify the nature and extent of contaminated soil and waters of the state and the sources thereof; identify current and potential impacts to public health, welfare and the environment; identify present and reasonably foreseeable future uses of the land and groundwater; and obtain and evaluate any other information necessary for identification and comparison of alternative remedial actions. Proposed Remedial Objectives are the clean-up goals determined for a specific site and consider the current and reasonably foreseeable uses of land and waters of the state.

The Shannon Road/El Camino del Cerro WQARF Site consists of a contaminated groundwater plume located in the vicinity of Shannon Road/El Camino del Cerro in Tucson, AZ. The site is bounded approximately by Orange Grove Road to the north, Meadowbrook Park to the east (north of the Rillito River), Shannon Road to the east (south of the Rillito River), El Camino del Cerro Road to the south, and Camino de la Tierra and the Santa Cruz River to the west. The current and primary contaminants of concern at the site include tetrachloroethene, trichloroethene, 1,1-dichloroethene, cis-1,2-dichloroethene and vinyl chloride. Contaminants of concern at the site may change as new data become available.
