



# MILITARY EXEMPTION

## APPLICATION FOR MILITARY VEHICLE EXEMPTION ARIZONA VEHICLE EMISSIONS INSPECTION PROGRAM

For Arizona residents on Active Military Duty, with a current set of orders for temporary deployment “Overseas”, “At Sea” or for “National Emergency Response.” You may qualify for a one year military exemption.

**This exemption is intended to allow the vehicle to be parked and remain registered while the member is away performing duties.**

**This form does not apply if your vehicle is being driven, for use with Temporary Duty (TDY), or performing a Permanent Change of Station (PCS). If the vehicle is being driven then apply with the “Out of State” form.**

1. Application should be completed within 90 days of deployment.
2. If you are stationed within the United States or its Territories, a regular “Out of State” exemption should be used.
3. The vehicle **MUST** be registered to the applicant.
4. You must provide a valid copy of orders to show deployment status.
5. This form must be complete with your Commanding Officer or Staff Judge Advocate signature or this form will be voided.
6. Send this completed **original** application , a **copy** of orders and a **copy** of the Arizona registration renewal form along with the **\$9.50** processing fee (check/money order payable to ADEQ), and a self-addressed/stamped envelope to:

When approved, a Military exemption certificate will be sent to you. The member may then go online to [www.servicearizona.com](http://www.servicearizona.com) and re-register the vehicle or renew by mail at the Motor Vehicle Division. For a new Arizona vehicle registration please contact the MVD.
