Please refer to Form 222 (www.azdeq.gov/environ/water/permits/download/222.pdf) for guidance on what should be submitted with this application and the number of copies. Please see the document entitled Application Submittal Locations to determine where to submit your application (county, city, regional office).
2. There are no fees associated with submitting an Engineers Certificate of Completion.
3. Satisfy any deficiency requests arising from the Department’s post-construction review of the submitted information.
4. Receive an “Approval of Construct” from the Department authorizing use of the water system.
