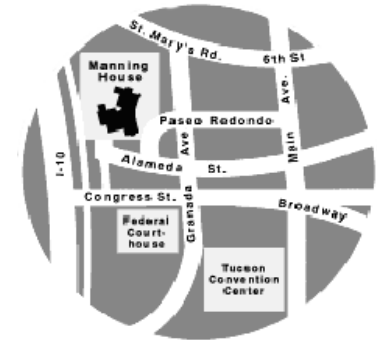

## Map and Driving Directions to Southern Arizona Forum on Children's Environmental Health

*Heading west into Downtown Tucson on Broadway Blvd.*

Head west on Broadway into downtown ending up on Congress, a one-way street. At the last stoplight before reaching Interstate 10, make a right turn onto Granada and head north. Go two blocks. The first street, Alameda has a stop light. The next street is Paseo Redondo. Make a left turn on Paseo Redondo heading west.

*From interstate 10/Broadway-Congress Exit*

From Interstate 10 and the Broadway-Congress exit in Tucson, take Congress east into downtown Tucson. At the first stoplight after the frontage road, make a left turn onto Granada heading north. Go two blocks. The first street, Alameda has a stop light. The next street is Paseo Redondo. Make a left turn on Paseo Redondo heading west.

The Manning House is located at the end of Paseo Redondo behind the circle of palms. Follow the entrance drive on the left of the building to the complimentary parking located on the west side of the building.
