## **Sixteen New Members Added in Largest Expansion Ever to ADEQ's Green Business Automotive Program**

PHOENIX (May 1, 2009) – Sixteen new auto shops around the state have been added to the Arizona Department of Environmental Quality's Green Business Automotive Program in the largest expansion in the four-year history of the program, which recognizes and encourages environmentally friendly car repair practices.

The new members – nine in the Phoenix metropolitan area, six in Tucson and one in Sedona – bring to 46 the number of shops participating in the program. The new members are:

**Phoenix and area** – Tony's Auto Service Center, 5602 E. Thomas Road;  
ToyoMotors Auto Care, 2818 E. Bell Road;  
Action Auto Repair, 2050 W. Deer Valley Road;  
Mike's Sun City Union, 10120 W. Bell Road in Sun City;  
Wilhelm Automotive at five locations: 3900 E. Estrella Pkwy. in Goodyear; 8245 N. Grand Ave. in Peoria; 29233 N. Cave Creek Road in Cave Creek; 13973 Indian School Road in Litchfield Park; and 14297 N. Grand Ave. in Surprise.

**Tucson** – Six Brake Max locations: 991 N. Pantano Road, 2240 N. Silver Bell Road, 2756 S. Kolb Road, 6055 W. Jenna Nichol Lane, 3245 N. Swan Road, and 15330 N. Oracle Road.

**Sedona** – Red Rock Precision Motors, 1425 W. Highway 89A.

Governor Jan Brewer praised the rapidly expanding program, saying, “this public-private partnership is another great example of cooperation of government and the private sector in conducting automobile repair in an environmentally responsible manner by recycling, using low-hazard components and disposing of harmful chemicals properly. I commend Arizona's AAA, the Automotive Service Association of Arizona and the City of Mesa for being such great partners in greening Arizona.”

The innovative green auto shops program is a public-private partnership which was launched with the Automobile Association of America-Arizona (AAA) in 2005. The program now includes the Automotive Service Association of Arizona and City of Mesa.

Participating shops make a significant environmental impact by eliminating or reducing hazardous waste going to landfills and diverting potentially contaminated water from unprotected storm drains and waterways. The shops examine their front-office processes, parts-management programs, housekeeping, parts cleaning and degreasing, fluid recycling and energy-use policies to reduce or prevent pollution
