

AMENDMENT TO

Delegation Agreement

Between

Arizona Department of Environmental Quality

and

Pinal County, a political subdivision of the State of Arizona, acting by and through the Pinal County Development Services Department

Delegation Agreement #06-0028

The delegation agreement between the Arizona Department of Environmental Quality and Pinal County, #06-0028, is amended by modifying the original text and appendices with the following:

Whereas A.R.S. § 49-107, authorizes the Director of the Arizona Department of Environmental Quality (ADEQ) to delegate to a local environmental agency, health department or municipality or county board of health established under Title 36, Chapter 1, Article 3, any functions, powers, and duties which the Director believes can be competently, efficiently, and properly performed by the local agency, and

Whereas Pinal County is a local agency (hereinafter referred to as LA) as set forth in A.R.S. § 49-107, and

Whereas A.R.S. § 11-201(A)(3) and A.R.S. § 11-952 authorize the County Board of Supervisors (and by delegation the LA, where LA is a county agency) to enter into contracts as necessary to assist LA in exercising its powers, and

Whereas LA deems that it is in its best interests to expand the specific delegation under A.A.C. R18-9-A316(E)(1) relating to the Notice of Transfer of ownership for property with an on-site wastewater treatment facility for which construction was completed before January 1, 2001 (Notice of Transfer), and

Whereas LA deems that it is in its best interest to discontinue the specific delegation of functions and duties of Title 18, Chapter 5, Article 2 and associated provisions of Appendix A of Agreement #06-0028, regarding Public and Semipublic Swimming Pools Approval to Construct and Approval of Construction.

Therefore, the Director of ADEQ hereby delegates Notice of Transfer under R18-9-A316(E)(1) to the LA, and the LA agrees to accept the expanded delegation of authority to perform those functions and duties described in A.A.C. R18-9-A316(E)(1), and to discontinue authority to perform functions and duties of Title 18, Chapter 5, Article 2 and associated provisions of Appendix A of Agreement #06-0028, regarding Public and Semipublic Swimming Pools Approval to Construct and Approval of Construction pursuant to the LA's express request for concerning these authorities, and in accordance with the amendment of Appendix A below:
